I am wondering what those 4 very large metal posts are for? They are by the walkway between the tennis courts and the parking lot (at the end closer to the tennis courts)

Also, I see that there's been a bucket lift in the parking lot for days now. I was hoping Luis was finally going to cut down the euc sprouts he told me he was going to cut down a couple years ago. With the bucket lift he could easily take them down. Once they are down its easy to remove the sprouts each year, if you do it early enough you can snap them off with your hands.

The weed whacking is nice but unfortunately with the moisture in the ground it will just grow back and they'll have to do it again. Their time would be better spent taking down those sprouts as there are quite a few now and each year they keep getting taller. Can you talk to Luis about finally removing them?

Also, there is what I believe is a yew tree on the hillside near my barn. it has small leaves that will easily ignite and the crown has grown right up into a euc. The yew is on the hillside and can easily be dropped by just one person with a couple chain saw cuts. They really should remove it as it is a fire ladder.

I want you to know that I have talked to Luis several times and though he promises he is going to do things they never seem to get done. It has been very frustrating. I am hoping you can intervene and see that the things I brought up (all easy maintenance issues) are finally taken care of.
